## Special UEN (SUN)

You are able to choose a preferred UEN from a list of reserved UENs, at a fee during entity incorporation/registration and entity conversion process.

There are 2 categories available:

- Tier 1 number, at a fee of \$\$3,000, which is defined as number with consecutive same number, or any number combination involving the number '8'
- Tier 2 number, at a fee of \$\$1,000, which is defined as number with repetitive pattern (excluding the number '8'), or ending with triple identical number (such as '222', '666', '777')

If you do not wish to select a SUN, the system will issue a free system-generated UEN to the business entity.

## **Terms & Conditions**

- A Special UEN is system-generated and cannot be amended or otherwise customised by an applicant. An applicant may select only one Special UEN for each business entity.
- ii. A Special UEN that is selected by the applicant will be reserved for him for 30 minutes pending his payment of the fee for the special UEN. If he fails to make payment within this time, the reservation will lapse and the Special UEN selected will be withdrawn and made available to other applicants. In addition, if a Special UEN selected by an applicant cannot be issued due to any other reason including a system error, it will be withdrawn and made

- available to other applicants. The applicant may however choose to select this Special UEN again if it is still available.
- iii. Upon successful payment of the fee for the Special UEN, it will be issued for the applicant's business entity.
- iv. Any fee that is paid for a Special UEN is not refundable.
- v. A Special UEN that is issued cannot be transferred by a person to any other business entity, and cannot be exchanged with any other Special UEN whether issued or not.
- vi. ACRA reserves the right to withdraw a Special UEN that is reserved or issued for a business entity, if for any reason the same Special UEN has already been reserved or issued for another business entity due to any reason including a system error. In this event, the applicant of the first business entity may select a new Special UEN.
- vii. ACRA may vary these terms and conditions at any time without notice.
